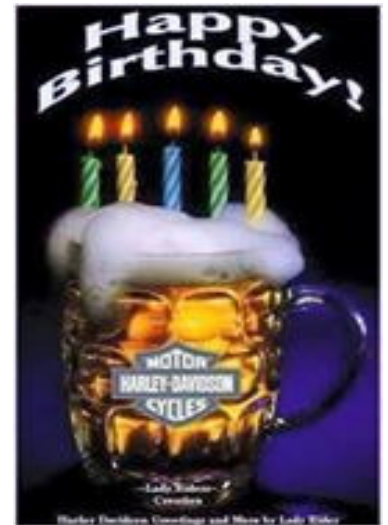

Service seminars are going to be every Saturday in February. Sign up for that will start soon so watch your email!

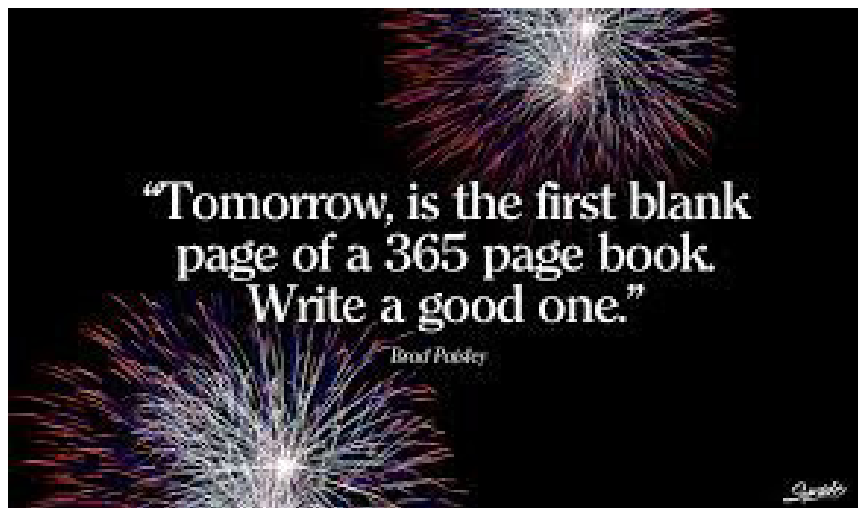
