Hello Kenosha HOG!

Are we ready to saddle up and RIDE! While it's still a little chilly, even those of us die-hards without heated gear can put the iron horse on the road now that Spring has finally sprung!

If you haven't already done so, be sure to check tire pressures cold. Go over your bike now and often to check for loose fasteners, tire wear, anything dragging under the bike...ya know, the obvious. Sometimes it's not so obvious until you're looking for it.

This is also perfect timing to go over the gear you carry. Road Captains are required to carry a basic first aid kit, also a good idea for any of us. Any pharmacy has pre-planned kits, or go to <http://www.redcrossstore.org/> to find what's appropriate for you. I also keep some basic OTC meds, aspirin, antihistamine, anti-diarrheal, and antacids. From experience, it's useful to have these at your disposal on rides where civilization is out of reach. Always consider the potential liability for yourself before sharing even these simple medications with others.

I keep a small bag of tools, a few plumber's candles AND matches in a sealed plastic bag, charging cords for electronics, and some snacks. I have a toothbrush in practically every jacket I own. I also carry a change of underwear (for close calls), a clean t-shirt, socks, spare gloves, a towel, and rain gear. Packed tightly, this leaves me about half my saddlebag space, plenty of room for anything you think I might need for a particular trip, or something I pick up along the way. Think small!

If there's something you have been wanting to add to your gear, or accessories for your bike, get it now so you can evaluate it for the whole season. Maybe you'll add it to your basic gear, or maybe you'll find that it wasn't necessary. But adding it now gives you a chance to see if it would be handy to carry all season long.

Another valuable addition to a ride is a new member! Whenever new members show up, we need to welcome them, and encourage them to get in on some of the fun! If someone became a member because they know you, then you are their primary ambassador to HOG. Introduce them to other people with similar interests in our great Chapter, and be sure they get the most out of their membership. When you see a new member on a ride, thank them for coming along, and offer your experience getting to know others. We were all new, once, and wanted to find our fit.

Most of all, pack some fun rides into this season. The Road Captains have come up with some fabulous new ideas, and we will be keeping tradition with Baraboo Memorial Ride, Monroe Cheese Ride, Darien Corn Fest, Fish Boil, Holy Hill, Fall Colors, and many others. The new rides look to be exciting, and I'm looking forward to getting my 10,000 miles for dinner with Keith. Let's all try to be there!
